Heather Minnich – Harter/Colorful Creations WAIVER AND SAFETY FORM

All stained-glass students are required to complete and sign a liability waiver, as well as read and agree to abide by the safety procedures as outlined by Colorful Creations Stained Glass, Heather Minnich – Harter, the Troy-Hayner Cultural Center, and the Friends of the Hayner, Inc. Please read and sign the document prior to the start of class.

- The participation age limit is 14 yrs and up.
- Students under the age of 18 yrs must be accompanied by a parent or guardian.

PHYSICAL REQUIREMENTS

Although there will be some sitting during the course, often there will be long periods of standing to complete certain tasks. This type of class is not appropriate for people with back, neck or shoulder problems, carpal tunnel syndrome in hands/arms or who cannot stand for periods at a time. Stained glass classes are not suggested for pregnant women due to the lead in the solder.

SAFETY IN THE GLASS STUDIO

- ~ Always wear safety glasses when cutting/grinding glass and when using equipment.
- ~ Keep hair tied back.
- ~ Refrain from wearing loose hanging articles of clothing or jewelry.
- ~ Wear closed footwear such as running shoes. No flip flops or sandals.
- ~ Wear long pants or apron during class.
- ~ Observe safety protocols for each piece of equipment as outlined by the instructor.
- ~ You may bring a drink in a sealed container, but it must be kept away from your work surface
- ~ For health & safety reasons, there will be no eating or drinking while soldering.

WAIVER

In connection with my involvement in art glass classes provided by Heather Minnich - Harter, I hereby release Heather Minnich - Harter, the Troy-Hayner Cultural Center, and the Friends of the Hayner, Inc. its agents, representatives, successors or assignees, from all liabilities, actions, claims, damages, demands, costs, and expenses which I now or in the future have against them, arising out of or in any way connected with my participation in art glass classes, including enroute to or from the program or its related events. I am aware that the use of, and proximity to, glass and certain supplies, tools and chemicals associated with stained glass composition may be a hazardous and dangerous activity. I also understand that this waiver includes, but is not limited to, any claims that are based on my alleged negligence or any other action or inaction of any of the above parties. By acknowledging I've read this form, I acknowledge I have read and understood the safety issues, waiver and class requirements that have been outlined, and voluntarily agree to be legally bound by these terms.
